Thank you for your interest in Night Flight Concepts' Trade-Up Program. The following process describes the steps you can expect if you choose to participate in this program. Night Flight Concepts can accept used AN/AVS-9 & AN/AVS-6 NVGs from L3 (M949) or Harris/ITT/Exelis/Elbit (F4949).

New goggles will be a one-for-one exchange for your trade-in and come with an operators manual & lens caps (no case or mount). NVGs eligible for trade-up must have a "readable" manufacturer serial number affixed to the NVG housing & pass an FAA 180-day inspection (will be provided by Night Flight Concepts).

READY TO TRADE-UP?

1. Email Night Flight Concepts a list of NVGs to Trade-Up, please include:
 - ▶ Make of NVGs to be traded-up (Example: Elbit, Exelis, Harris, ITT, L3 Litton)
 - ▶ Model of NVGs to be traded-up (Example: AN/AVS-9, AN/AVS-6)
 - ▶ Manufacturer Serial Number(s)
2. Ship trade-in NVGs to Night Flight Concepts once RMA is provided
 - ▶ Send your NVGs in a shipping or storage case (pack storage cases in shipping box)
***Shipping and storage containers will be returned with you new NVGs*
 - ▶ Include lens caps and operator's manual
 - ▶ Include hard-copy of your signed Purchase Order for new NVG
 - ▶ On the outside of shipping box, write RMA number provided by Night Flight Concepts
 - ▶ Ship NVGs to the following location:

3. Upon receipt of trade-up goggles, Night Flight Concepts will evaluate your NVGs within 72 hours and will send customer a Trade-Up Goggle Evaluation and a Transfer of Ownership form. Customer is to sign and email the Transfer of Ownership form back to the Night Flight Concepts sales representative.
